MINOR WAIVER AND RELEASE OF LIABILITY

The insurance policy of the South Jersey Young Guns Baseball will be considered secondary to any existing insurance. I understand that in my absence, emergency medical treatment may be administered to my child until such time I can be contacted. I have read and understand all of the Parent's Code of Ethics and agree to fulfill my obligations as described within it. I agree to the terms and conditions of this liability release and give my permission for my child to participate in this youth activity.

1. THAT I HAVE READ AND UNDERSTAND THE CONTENTS OF THIS WAIVER AND RELEASE OF LIABILITY. I REPRESENT THAT I AM AUTHORIZED TO EXECUTE AND SUBMIT THIS APPLICATION ON BEHALF OF THE MINOR PARTICIPANT.

I agree, represent and affirm that the minor participant is in good health and good physical condition and does not suffer from any disability that would prevent or limit their voluntary participation in South Jersey Young Guns clubs/leagues, clinics, lessons, open play, related activities and special events.

I agree that I, as parent(s) and/or legal guardian(s), will instruct the minor participant that prior to participating, he or she should become or be familiar with the operation of, and inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.
